- Once enrolled in college and taking 6 or more units no more GAIN, job search – go to college now. No sanctions for going to college.
- Must meet the 20/30/35 hours requirements each hourly instruction of equal to 1 hour plus 3 hours of study time.
- Get \$500 for books 10 days before the beginning of the semester and \$350 for part-time attendance

Study time is 3 hours per one hour class. One hour is 50 minutes of classroom time.

- Just one orientation and "assessment" is done just for identifying barriers. Student right not to do it in person – by phone or in writing
- That pesky "satisfactory progress" determined by the county – gone – enrollment in college meets the "satisfactory progress" requirement

 If your books and school supplies exceed \$500/\$350, you can request a supplemental payment

 You can use the CCWRO <u>form</u> to get ask for the supplemental payment.

AB 2452

•AB 2452 (D) Quirk-Silva would provide a standard \$100 a month transportation payment to CalWORKs WtW participants, including students

SB 1415

•**SB 1415** (D) Senator Glazer would provide a standard \$700 one- time college startup costs that would cover the cost of such things as a laptops, etc.

AB 2033

 Before September 1, 2025, each campus of the California Community Colleges and each campus of the California State University, and request each University of California campus must have a food store that accepts an EBT card; and

• Each campus of the California State University, and request each University of California campus must have a basic needs coordinator.

AB 2458 (D) - Berman

- AB 2458 would require each campus of the California Community Colleges (CCC) and the California State University (CSU), and requesting each campus of the University of California (UC), to:
 - (1) develop and implement a campus policy for estimating and adjusting cost of attendance information for student parents, as specified;
 - (2) establish a data field in the campus's data management information system to identify student parents for certain purposes; and,
 - (3) update its campus net price calculator to include a baseline student parent cost estimate, as specified.

Child Care for Students

- Any student who has a child under the age of 13 is eligible for full-time child care, even if you are taking less than 12 units.
- How to request child care. Go to BenefitsCal and type in "I want full time child care for my children – name of children- because I am going to college.
- If you do not get child care within 10 days, ask for a state hearing. That is what the welfare department gives us to get the verification they want. EQUITY. You can also use our <u>form</u> to get child care at <u>ccwro.org</u>

College Student Transportation

- Mileage
 - One hour each way from your home to the school classroom and from the classroom to your home. The 1 hour includes walking time to the bus stop from your home and walking time from the classroom to the bus stop.
 - It also includes the bus ride time, including time waiting to transfer from one bus to another.
- Bus pass
- Advance pay request
- How to request transportation and advance pay

How to Request a LapTop/Transportation and Child Care

- Go to BenefitsCal and open up an account
- Go to your next appointment
- Scroll down to "What else would you like to do?
- Scroll down to "Get support from your caseworker to manage your benefits and click on "I want to request support"
- That would take you to "Support Requests"
- Click on "Supportive Services

How to Request a LapTop/Transportation and Child Care

 That should take you to "How can we help you with supportive services?"

For laptops click on "Other Ancillary Services

For transportation click on "Transportation"

For childcare click on Child Care

How to Request a Laptop/computer
